Description:

The municipality of Svetvinčenat is located in the southern part of central Istria, 2,202 inhabitants in 2011. It borders the Municipality of Kanfanar to the northwest, the Municipality of Žminj to the northeast, the Municipality of Bale to the west, the Municipality of Barban to the east, the Municipality of Vodnjan to the south, and the Municipality of Marčana from the southeast side. Svetvinčenat, Savičenta, San Vincenti, three names of the same place, which have their origin in the name of the patron saint, the Spanish martyr St. Vincentius and the abbey of the same name, around which the town developed. By investing in the creation of an additional tourist offer, we strive to develop cultural, historical, religious and rural tourism based on traditional and authentic elements of local architecture and the preservation of cultural heritage, eno and gastronomic tourism, active vacations in nature, and the creation of centers for year-round mountain and sports tourism, cycling and hiking trails, thematic routes, modernly equipped congress centers and visitor centers.
