ISTRIA, LIŽNJAN - Modern house with swimming pool! Close to the sea! The municipality of Ližnjan-Lisignano is located in the extreme southeast of the Istrian peninsula, not far from the largest city in the Istrian county, the city of Pula. As a local self-government unit, it covers an area of 69.87 square kilometers, which is about 2.47% of the area of Istria County. The municipality of Ližnjan-Lisignano is surrounded by the sea on its southern and eastern sides. On the southwest side, it borders the municipality of Medulin, on the west side with the city of Pula, and on the north side with the municipality of Marčana. It stretches along a coastline about 27.6 kilometers long and includes numerous coves. Approximately 1,800 hectares of the area of the Ližnjan-Lisignano municipality belong to the coastal area. A detached house of modern design, consisting of a ground floor and a first floor, is located in a quiet part of Ližnjan. On the ground floor there is an entrance area, living room and dining room, hallway, kitchen, utility room, engine room, toilet and an internal staircase leading to the first floor where there are three bedrooms with private bathrooms as well as three uncovered terraces. An interesting part of the interior layout is the just-described floor of the house, which communicates with the terraces from the bedroom or common corridor, therefore the property guarantees quiet, magical mornings with an open view of the greenery that stretches behind the house. The ground floor, through glass walls, offers communication with the terrace and the fenced garden, where there is a swimming pool, a barbecue area, a sunbathing area, a playground and parking spaces. Considering the location near the sea and the unobstructed view of the environment and greenery, the property represents an excellent opportunity for family life or as an investment for rental for tourist purposes.
