> building plot located in an urbanized area at the microlocation Pužev Brijeg. The land has a relatively gentle slope, although it is irregularly shaped, with a partial view of the Kvarner Bay. Water and electricity are in close proximity to the plot, and the area is connected to the sewage system. The plot has access from an asphalt road, and according to general building conditions, an individual residential building can be constructed with a maximum gross floor area of 600 m². Up to 3 above-ground floors are allowed, with a maximum height of 9 meters to the eaves and 11 meters to the roof ridge. A maximum of 3 apartments + 1 commercial unit (up to 33% of the gross floor area of the above-ground part of the building) is permitted. The distance from the boundary is 6 meters from the road surface and 4 meters from other borders. The area where the building can be placed based on these distances is 189.3 m². Kig = 185.1 m² (ground floor area of the building). Kis = 555.3 m^2 (total gross area of all floors). This land is certainly worth considering, both for the construction of an apartment building and for an urban villa, and comes with our warm recommendation for all investors and lovers of the Opatija Riviera!
