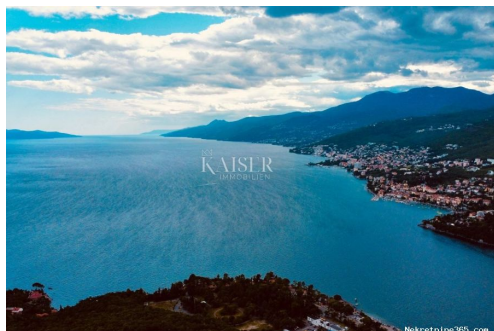

The highest allowed building coefficient is 0.25 for a detached building, and 0.3 for a semi-detached building. The highest permitted coefficient of utilization is 0.6 for a detached building, and 0.8 for a semi-detached building. The surface of buried parts is not included in the calculation of the coefficient. Construction (kig) and utilization (kis). Typology of buildings: For family houses, the largest building (gross) area must not exceed 400m² (in which the area of auxiliary buildings is included), and contain at least 2 residential units. For multi-family buildings, the largest gross area does not exceed 500m² (in which the area of auxiliary buildings</p>
