Istria, Labin, surroundings - Land for tourist purposes (T2) for the construction of tourist catering facilities 32,322 m2. It is located in an almost untouched part of the coast of eastern Istria with an open view of the sea, Kvarner and the islands of Cres, Lošinj, Unije, Krk. It is located in a small settlement located below the Labin-Rijeka road, and belongs to the municipality of Kršan. The land has access to the sea and a wild beach, to which access is possible only through this land. According to the spatial plan, the land is located in part of the construction area for tourist and catering purposes. In the immediate vicinity of the land there is existing infrastructure (water, telephone and electricity). There are also three beautiful beaches nearby, Bobina, Brestova and Stupova, and the land has access to a beautiful wild beach. Access to the land is directly from the paved road. It is for catering and tourist purposes and the construction of apartments, hotels and accompanying facilities for service, catering-tourism, reception buildings, entertainment, recreation, sports and similar purposes is allowed. One of the special features of the location is that the construction of a golf course is foreseen in the planning documentation in the neighboring town Eastern Istria in the stretch from Labin to Rijeka with perhaps the most beautiful views of the sea in the northern Adriatic. The road distance from Labin is 20 km, to Mošćenička Draga 10 km. Opatija 30 km distance and Rijeka about 40 km. In the immediate vicinity is the ferry port of Brestova with a connection to the islands of Cres and Lošinj. Istria, Labin, surroundings - Land for tourist purposes (T2) for the construction of tourist catering facilities 32,322 m2 is an interesting property, an ideal opportunity for investment with great potential in an environment of untouched nature with a completely open view of the sea and the Kvarner Bay.
